Copy of the proceedings in the matter of an application, No.U-188/408, dated 29th August, 1983, from the Principal, Sadhana Education Society's Smt. Kapila Khandwala College of Education, Santacruz, Bombay, for the permanent affiliation of the college for the teaching of the courses of study for the degree of Bachelor of Education (B.Ed.).

On receipt of the application the Executive Council appointed a local inquiry committee consisting of the following members to report thereon :-

Dr.(Kum.) M.D. Bengalee  
Prin. B.P. Lulla.

The report of the local inquiry committee was considered by the Academic Council and the Executive Council at their meeting held on 26th June, 1985 and 30th July, 1985, respectively.

The resolution of the Academic Council and thereport of the Executive Council are as follows :-

#### Resolution of the Academic Council

It was resolved that it be reported to the Executive Council that, in the opinion of the Council the Sadhana Education Society's Smt. Kapila Khandwala College of Education, Santacruz, Bombay, be granted permanent affiliation for the teaching of the courses of study for the degree of Bachelor of Education (B.Ed.) with retrospective effect from 20th, 1984, on the condition that the Principal is provided with suitable residential quarters before 20th June, 1986, in the college campus or at a suitable place nearby.

Resolved further that it be recommended to the Executive Council that the college be permitted to admit 100 students to the B.Ed. degree course as at present.

#### Report of the Executive Council

The Executive Council, after considering the report of the local inquiry committee and the resolution of the Academic Council thereon, report to the Senate that it is of the opinion that the affiliation of the Sadhana Education Society's Smt. Kapila Khandwala College of Education, Santacruz, Bombay, to the University for the teaching of the courses of study for the degree of Bachelor of Education (B.Ed.) be made permanent with retrospective effect from 20th June, 1984, on the condition that the Principal is provided with suitable residential quarters before 20th June, 1986, in the college campus or at a suitable place nearby.
