A code of conduct is a necessary component for any Institution to maintain standards for the

and trust to the individuals that the profession serves.

The Code applies to all Sadhana Education Society's Smt Kapila Khandvala College of Education

(KKCE) representatives be that staff, trustees, volunteers, consultants and all those connected with

the activities of KKCE regardless of location, and in accepting appointment or in other ways

representing KKCE.

KKCE considers a code of professional conduct as a necessary component to maintain standards for

the individuals within the organisation or working with the organisation, to adhere to.

The aim of this Code of Conduct is to reinforce the standards by which one needs to behave in all

circumstances.

KKCE expects its representatives to act in accordance with the key principles contained within it. This

Code of Conduct works within the framework of Indian laws and relevant UN and International

Standards and is also bound by the Sexual Harassment of Women at Workplace (Prevention,

Prohibition and Redressal) Act. 2013. and Commitments and the UGC's Prevention, prohibition and

redressal of sexual harassment of women employees and students in higher educational institutions)

Regulations, 2015. This Code of Conduct applies to all KKCE representatives and must be signed by

those directly appointed by KKCE as faculty, students or consultants.

Code of Conduct:

- Harassment: KKCE has zero-tolerance towards harassment of members of affected communities, any representatives of KKCE or any others connected with the work of KKCE, and all representatives have a duty to report inappropriate behavior.
- Sexual Exploitation and abuse is dealt with in our SEA policy and KKCE will not tolerate sexual exploitation or abuse of beneficiaries, any representatives of KKCE or any others connected with our work, and is expected that representatives report inappropriate behavior when they know of it.
- Behavior towards children & Adults at risk: Anyone associated in any capacity with KKCE will not abuse or exploit children (defined as less than 18 years old) or vulnerable adults sexually or otherwise.
- ❖ If a residential event is being planned, ensure that children, women and vulnerable adults have safe sleeping arrangements.
- The adult must always behave responsibly even if a child does not adhere to the accepted behavior or makes advances sexually.
- Will ensure that their behavior is not exploitative, abusive or corrupt in any way even in offduty hours and other locations other than the campus.
- Treat everyone with respect, recognizing their right to personal privacy
- ❖ Be aware of situations that may present risks and manage these and also plan and organize events so that risks are minimized.
- Will not misuse Official Confidential Information in any capacity. They will ensure that KKCE information, funds and resources (including money, vehicles, computers including the use of email and internet, telephones, photocopiers, fax machines and stationery etc.) entrusted to them to be used responsibly and account for all money and property, following the appropriate policy and procedural requirements. They will also abide by KKCE's Data Protection Policy.

- They will treat all people fairly and with respect and dignity, will not use unequal power relationships (for example with students in practicing schools or students) for own benefit and work with others in an open and participative way.
- They will also not be under the influence of alcohol whilst working or volunteering for KKCE and will not use or be in possession of, illegal substances at any time.
- They will not accept gifts or any remuneration from governments, beneficiaries, partners, donors, suppliers and other persons, which have been offered to them as a result of their association with KKCE and will not participate/facilitate any commercial sex transactions.
- They will conduct private life in a manner that avoids possible conflicts of interest with the work of KKCE and avoid involvement in any criminal activities.
- They will fully abide with the requirements of KKCE's diversity and inclusion and antiharassment policies and will never knowingly engage in any exploitive, abusive or corrupt relationships and will take appropriate action if aware of them.
- They will not enter into a sexual relationship with any beneficiary of assistance since such relationships are based on inherently unequal power dynamics and undermine the credibility and integrity of the work of KKCE.
- They will not sexually harass, exploit or abuse any colleagues or others that they come into contact with in the course of their work.
- They will ensure that they have read and understood the safeguarding policy including the definitions of sexual harassment, exploitation and abuse.

KKCE has a zero-tolerance policy towards sexual exploitation and abuse.

The UN defines sexual exploitation and abuse SEA as follows:

a. Sexual exploitation is any actual or attempted abuse of a position of vulnerability, differential power, or trust, for sexual purposes, including, but not limited to, profiting monetarily, socially or politically from the sexual exploitation of another.

b. Sexual abuse means the actual or threatened physical intrusion of a sexual nature, whether by force or under unequal or coercive conditions.

All members/stakeholders associated with KKCE as an institution are expected to not indulge in SEA and also report any such act that they witness to the authorities as per procedures described in the Internal Complaints Cell and the Woman's Grievance Cell as per guidelines of the SEA Policy. Action will be taken as per the UGC's Prevention, prohibition and redressal of sexual harassment of women employees and students in higher educational institutions) Regulations, 2015.
